IMPORTANT: By submitting payment, AG Injury Law acknowledges and accepts this invoice and the Retainer Terms on Page 2 as the complete agreement between the parties. The initial engagement is a minimum of three consecutive monthly billing periods (90 days), at \$2,000 per month, for a minimum commitment of \$6,000, excluding processing fees and approved additional services.

This invoice, together with these Retainer Terms, constitutes the written agreement between The Makse Agency ("Agency") and AG Injury Law ("Client").

1. Acceptance and Authority

Client accepts this Agreement by submitting any payment toward Invoice #01626. Payment serves as Client's electronic acknowledgment that it has reviewed, understood, and agreed to all terms. The person authorizing payment represents that they have authority to bind AG Injury Law.

2. Minimum Initial Term

The initial engagement is a firm minimum of three consecutive monthly billing periods (90 days). The monthly retainer is \$2,000, creating a minimum contractual commitment of \$6,000, excluding payment-processing fees and any additional services approved in writing. Payment of Month 1 commits Client to payment of Months 2 and 3 even if Client pauses, reduces, or ends its use of the services before the initial term expires.

3. Advance Monthly Payment

Each \$2,000 monthly retainer is due in advance, before services begin for that billing period. Month 2 and Month 3 invoices will be due before the start of their respective service periods. Agency may pause production, editing, delivery, or scheduling while any payment is past due. A pause for nonpayment does not cancel or extend the minimum commitment.

4. Monthly Scope and Production Schedule

The monthly retainer includes the services listed on Page 1 and four on-site production days per month: two production days during Week 1 and two production days at the beginning of Week 3. Exact dates and call times will be mutually coordinated and confirmed in writing. Schedule changes requested by Client are subject to Agency availability. Unused production time does not automatically roll over unless both parties agree in writing.

5. Additional Services

Work outside the listed scope, including additional production days, extensive revisions, travel, talent, locations, specialty equipment, paid media, or third-party costs, requires written approval and may be invoiced separately.

6. Client Review and Legal Compliance

Client retains final approval over all public-facing content and is responsible for confirming the accuracy of legal statements, case results, testimonials, disclaimers, advertising language, and compliance with all professional-responsibility, bar-advertising, privacy, and confidentiality requirements applicable to the law firm. Agency provides creative and production services and does not provide legal advice.

7. Continuation After Initial Term

After the initial 90-day term, the parties may continue services on a month-to-month basis at the then-current rate unless replaced by a new written agreement. Either party may end any month-to-month continuation by written notice before the next monthly service period begins.

8. Entire Agreement and Written Changes

This invoice and these Retainer Terms contain the parties' entire agreement for the services described and replace prior oral or text-message discussions on the same scope. Any change must be confirmed in writing by both parties. Electronic communications and payment records may be used as evidence of acceptance and approval.

PAYMENT OF INVOICE #01626 CONSTITUTES ACCEPTANCE OF THIS AGREEMENT.

Minimum initial commitment: 90 days / three monthly retainers / \$6,000 total.
